



**TERMS OF USE FOR WWW.MESSINGHAMGRANGE.COM**

1. This website is owned and operated by Grange Park Golf and Leisure Ltd trading as Messingham Grange. These Terms set forth the terms and conditions under which you may use our website and services as offered by us.
